This puppy is the product of two genetically health tested AKC/ASCA registered purebred Australian Shepherd parents.

A \$300 non-refundable deposit with completed contract is due at the time of puppy selection. If after 5 business days, the deposit has not been received, the puppy will be made available for sale. Contracts can be mailed or e-mailed with signed signatures. Puppies are not considered reserved until the deposit and contract are received. If any

injury, sickness, or death should occur to this puppy while in our care, all monies paid will be refunded.

Puppies will not be released to go to new homes until 8 weeks of age. Buyer has until 9 weeks of age (unless otherwise agreed upon) to make final payment of puppy. Puppies will not be released until final balance is paid in full. If after 9 weeks of age, final balance has not been paid, puppy will be made available for sale. If puppy has been paid for in full, but not picked up by 9 weeks, Buyer will be charged an additional \$50 per week boarding fee.

Puppies will be vet checked at 8 weeks of age for a full health evaluation, and will receive their first set of vaccinations and deworming before leaving. Buyer will be charged for additional vaccinations and veterinarian costs if kept beyond 8 weeks. Puppy described above is deemed healthy at receipt. Seller is not responsible for any stress related illness due to transporting. Buyer agrees to take puppy to the vet within 72 hours of receipt or this contract becomes null and void. If the puppy is found, by a licensed veterinarian, not to be in good health (internal/external parasites and kennel cough excluded), Buyer must notify Seller within 24 hours with a report from a licensed veterinarian. Failure to provide a written report within 24 hours of exam invalidates this contract. Seller is not responsible for any fees incurred. Buyer agrees to provide fresh water and high quality food daily and to continue a strict health program of continued vaccinations, deworming, and parasite control.

In the event of puppy death within 30 days of receipt, a replacement puppy may be provided if the Buyer has a necropsy completed including a full blood panel and samples are sent to a state lab for testing. A report must be provided to the breeder within 30 days of the necropsy being performed. All expenses are to be paid by the Buyer. If the necropsy report determines the puppy died from an accident, toxin, abuse and/or neglect, or any other means outside of breeder responsibilities, no replacement puppy will be granted. This contract will be null and void.

All Pet/Non Breeding: Are required to be spayed /neutered at the age of 6 months and will be sold with limited registration to AKC/ASCA, and will be marked as such on the registration papers.

All Show/Breeding: Will be sold with full registration. Seller does not guarantee performance. If breeding, Buyer agrees to perform all necessary genetic and health testing as recommended by the AKC parent breed club and ASCA.

If at any time for any reason, the Buyer cannot keep described dog or puppy, Buyer agrees to contact Seller and offer animal back to Seller at no cost before it is offered to any other person or organization.
